Manuscript Submission

Authors should submit via email the MS Word file of the manuscript to The Editor of the Korean Social Science Journal, e-mail: kssjournal@gmail.com.

To protect anonymity, information about the author(s) should not appear on the manuscript. Instead, a separate cover page should be provided including: (i) a concise and informative title, (ii) name(s) of the author(s), the affiliation(s), (iii) full international contact details of the corresponding author(s) including E-mail address and telephone number, and (iv) a brief professional biography of the contributor(s) to be included in the paper if accepted for publication. Authors may present acknowledgements of people, grants, funds etc. The names of funding institutions should be written in full.

Review Process

Each manuscript submitted to KSSJ is subjected to the following review process. (i) It is reviewed by the Editor for its general suitability for publication. (ii) When it has been judged suitable, reviewers are selected and a double-blind review process takes place. (iii) Based on the recommendations from the reviewers, an editorial decision is made on whether the submitted manuscript should be accepted as it is, revised or rejected.
